13TH JPC MEETING IN SKOPJE

The 13th JPC Meeting - European Union and the Republic of Macedonia was held in the Assembly of the Republic of Macedonia, chaired by Mr. Kenan Hasipi and Mr. Alojz Peterle. Mr. Fatmir Besimi, Vice-President of the Government in charge of EU Affairs, Mr. Nikola Poposki, Minister of Foreign Affairs and Mr. Aivo Orav, Ambassador and Head of the EU Delegation in the Republic of Macedonia exchanged views on recent developments with MPs and MEPs from both parliaments, with a particular focus on Implementation of the 2 June and 15 July agreements and the targets of the High Level Accession Dialogue, i.e. Rule of Law, judiciary reform and fight against corruption, Electoral reform and forthcoming parliamentary elections, Freedom of media, Inter-community dialogue. They also discussed the migration crisis: the challenges, management and possible consequences.

The Co-Chair Hasipi pointed out that with the return of the opposition in parliament, the JPC is completed and all conditions for having JPC meetings are fulfilled.

Co-Chair Peterle stated that his presence is to give support to the EU accession process of the Republic of Macedonia, the implementation of the political agreement and the necessary reforms in order to maintain the EC conditioned positive recommendation. He underlined that the political dialogue should continue and to

be implemented gradually in this spirit. At the end of the meeting, *Final Recommendations* were adopted.



PUBLIC DEBATE ON EU ENLARGEMENT STRATEGY

The National Euro-Integration Council held a public debate on the EU Enlargement Strategy. The aim was to exchange views on this mid-term strategic document, which encompasses the mandate of the European Commission and the new method of reporting on countries' annual progress. Members of EU Affairs, Foreign Policy Committee, JPC-EU and RM, NGOs, Embassy representatives were present at the meeting. Vice-President of the Government in charge of EU Affairs, Mr. Fatmir Besimi, stated that despite the challenges that EU is currently facing with, enlargement process continues to be on the EU agenda and that recommendations in the EC Progress Report for the Republic of Macedonia have been taken into account in the Action Plan for Implementation of Urgent Reform Priorities. In the debate, participants underlined that the EU Enlargement Strategy places the countries in the region in a system of comparison, but individual approach and individual assessment remains essential. The key areas in which the European



Commission expects progress by the Republic of Macedonia are: reforms in the judiciary and public administration, legislation implementation, full implementation of the recommendation in the Urgent Reform Priorities, transparency and implementation of the budget, and decisive steps to be taken in finding solution to the name issue.

STRENGTHENING OF THE SEECP PROCESS AS A LEADING POLITICAL FORMAT FOR COOPERATION IN THE REGION



The Vice-President of the Assembly of the Republic of Macedonia, Mr. Antonijo Miloshoski, took part at the International Conference titled: "SEECP Parliamentary Assembly - regional synergies, strategic cooperation and parliamentary diplomacy" in Sofia, Republic of Bulgaria. The Conference was chaired by Ms. Tsetska Tsacheva, President of the Bulgaria's National Assembly in the frames of the Bulgarian Parliamentary Presidency with the process and presented

the priorities in including continuation of the institutionalization of the SEECP PA, deepening of the cooperation with the European Parliament and greater involvement of young people in political life. The Bulgarian Deputy-MFA, Ms. Valentin Poryazov, referred to the goals and activities of the Bulgarian Presidency 2015-2016 titled: "SEECP - 20 years a key to cooperation in the region" aimed to strengthening of the role of the process, as a leading political format for regional cooperation, factor of stability, security and prosperity of the region. The Presidency will focus on three main areas of cooperation: 1) transport, energy and infrastructure, 2) freedom of media and expression, and 3) migration and influx of refugees. 13 Member States from SEECP national parliaments took part in the event, as well as representatives of regional parliamentary assemblies, NGOs and academic institutions.
