# **PRESIDENT VELJANOSKI AT THE** EUROPEAN CONFERENCE OF SPEAKERS IN OSLO

he President of the Assembly of the Republic of Macedonia, Mr. Trajko Veljanoski, attended the European Conference of Speakers in Oslo, where he took part in the debate on the "Majority and opposition striking a balance in democracy". President Veljanoski underlined that the opposition is a necessity in a democratic society and that the Republic of Macedonia as a young democracy in these 23 years worked hard to implement the best examples and practices from older, experienced and democratically proved states. Such examples include the appointment of one of the three Vice- Presidents of the Assembly from the opposition, as well as appointment of several Committee Chairpersons. In this context, he mentioned the fact that during the sessions dedicated to parliamentary questions, the opposition MPs have the right to pose twice as many questions than the MPs from parliamentary majority and that MPs from the opposition participate in all coordinative meetings and the meetings of the Presidency where the dynamics of the work of the Assembly is adopted. All these and many other mechanisms and practices are introduced to valorize the need for existence of the opposition and existence of a balance between the opposition and majority. President Veljanoski concluded that capability of the opposition to offer political alternatives for the decisions of the government and the representatives of the majority is needed and that in the democratic society, opposition should be a seen as a possibility for political changes through democratic means, thus providing active contribution in the political pluralism.

resident Veljanoski had a meeting with the First Prime Minister and Minister of Foreign Affairs of the Republic of Serbia, Mr. Ivica Dačić. The interlocutors discussed the current affairs in the region and the developments in their states as well, and expressed wish for integration of both countries in the EU as soon as possible. The joint session of the two governments and the Agreement on the Conditions for Travelling of the Citizens of Both States were underlined as positive examples of friendship.

The meeting was finalized with the statements of openness and preparedness for regional cooperation and progress between the two states.

## VICE- PRESIDENT MILOSHOSKI MEETS DG ENLARGEMENT REPRESENTATIVES



The Vice President of the Assembly of the Republic of Macedonia, Mr. Antonijo Miloshoski, had a meeting with a Delegation from the DG Neighborhood and Enlargement negotiations, headed by Mr. David Cullen. The visit of the delegation was realized prior the publishing of the Progress Report announced for 8 October. In this context, the Vice President Miloshoski expressed hope that the new Commissioner Johannes Hann will commit himself for the Republic of Macedonia.

He informed the delegation on the current affairs in the Parliament and in the state related also to the absence of the opposition in the Assembly, expressing hope to overcome the situation. Also, the meeting focused on the Draft – Decision on Amendment of the Constitution of the Republic of Macedonia in many areas, as well as to the IPA Funds. The meeting was an opportunity for the team of experts to be directly acquainted with the developments if the state and for deepening of the mutual cooperation.

## MACEDONIA SHARES POSITIVE EXAMPLE ON SUPERVISION OF IPA FUNDS

Ms. Nora Aliti, Deputy Chair of the Committee on European Issues toook part at the Conference of the Regional Network of Parliamentary Committees on Economy, Finance and European Issues organized by the Westminster Foundation for Democracy in Bosnia and Herzegovina. At the session dedicated to the use of IPA funds in the region, Ms. Aliti pointed out that the Republic of Macedonia is making efforts to improve the use of these funds and to implement the necessary EU reforms, and also to approach in a more coordinated manner for use of funds within the IPA Il framework 2014-2020 .In that context, she referred to the supervisory debate for the percentage of used IPA I funds as a positive example for other states in the region, which was organized by the Committee on European Issues last year, as a good example for parliamentary supervision on the Government in this field. Ms. Nora Ismajloska, Member of the Committee on European Issues, took part in the session dedicated to the promotion of the COSAP meetings, as a platform for exchange of view on Euro-integration processes with the countries in the region, emphasizing that COSAP meetings can significantly contribute to a faster and better fulfillment of the necessary criteria for EU membership and for promotion of joint regional interests of the participant states in the EU.



## TRANSPARENCY OF MEDIA OWNERSHIP CONFERENCE IN SKOPJE

At the Regional Conference dedicated to the Transparency of Media Ownership and Prevention of Media Concentration held in Skopje, representatives from the Committee on Transport, Communications and Environment took part at the event that was organized within the Council of Europe Project for Promoting Freedom of Expression and Information and Freedom of the Media in South-East Europe, financed by the Norwegian Government. Mr. Jean-François Furnémont, former chairman of EPRA and former Director General at Belgium regulatory authority talked about the challenges in the new media environment. Mr. Bernd Malzanini from the German regulatory authority



shared his experiences and practices from the implementation of measures that prevent media concentration and protect competition on media markets. Mr. Peggy Valcke,



Professor of Law at KU Leuven Faculty of Law presented his opinion on the media ownership and media concentration, and Ms. Biljana Petkovska from the Macedonian Institut on Media reflected on the integrity of media and journalism, citing conclusions and recommendations from the research made by the SEE Media Observatory. Representatives from the civil society also took part in the debate.
